NORTHEAST TEXAS COMMUNITY COLLEGE

This agreement between **Texarkana Community College** and **Northeast Texas Community College** is to encourage secondary students enrolled in specific dual credit Drama classes to continue their education and pursue a college degree in Theatre with NTCC.

Both institutions will share information to ensure all required course information is covered. Dual credit instructors will follow all dual credit procedures and guidelines to ensure collegial level instruction to eligible secondary students seeking college credit for competencies developed in high school. NTCC has the option to appoint a liaison to all dual credit teachers overseeing coursework for transfer.

Effective **August 2025** this agreement will need to be renewed annually at which time either party may request a change or termination of this agreement. It is agreed that students who enroll and successfully complete the specified Drama courses through the Texarkana College Dual Credit Program will be eligible to transfer specified course credit to Northeast Texas Community College toward the existing NTCC Theatre degree.

The course(s) agreed for transfer via this document are:

The conditions of the agreement were formulated through communication with representatives from both institutions based on the agreement on course content, objectives, and learning outcomes. Under this agreement, the following conditions are hereby set forth:

The Texarkana College dual credit director will initiate an annual review of this agreement with an NTCC representative to evaluate any changes in competencies, content, or standards.

Texarkana College will be responsible for evaluating instructor credentials to ensure they meet all accreditation requirements, including, but not limited to the Texas Higher Education Coordinating Board (THECB) and Southern Association of Colleges, Commission on Colleges (SACS-COC).

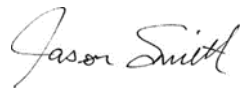
Northeast Texas College will provide required syllabi and applicable student learning outcomes for approved dual credit teachers to follow. Texarkana College will annually disperse all material to applicable teachers.

This agreement may be terminated in whole or in part by either party upon annual review. However, such termination shall not affect the transfer of student credit previously earned during the period of a signed agreement.

Dual Credit students successfully completing authorized college courses listed in this agreement will have those courses transcribed on a TC college transcript. Students must enroll at NTCC and meet all NTCC admission requirements for specified dual credit courses to transfer. Guaranteed transferability is only approved for up to five years after the high school graduation date.
